4.1. Budget Projections

The Committee reviewed the Operational budget for the 2020/2021 FY after the Public Consultation. The Committee reviewed the Tax Assessments and recommends to Council no changes except to Pleasant Grove who will be phasing in their Tax rate by .02 per year.

The Committee reviewed the Recreation Budget and they had asked for an increase in their last meeting to be able to replace some aging gym equipment and have new events. Committee agreed to up the Budget for Events and Recreation from 10, 500 to 13,000.

4.2. Capital Projections

The Committee reviewed the Capital Projects that have been pre-approved for the 2020-2021 FY and for the 5 year plan.

It was duly moved and seconded that the Operation Budget with Revenue of \$566,394 and Expenses of \$564,645 and a Capital Budget of \$372,280 with \$345,892 coming from Other Funding and Gas Tax and \$26,388 coming from the Capital Reserve Funds be accepted and recommended to Council.

4.4. Infrastructure

Gerard Watts asked if we have gotten all the quotes from Grand Tracadie as of yet. CAO Stephanie Moase has been working on getting them but has had issues finding people to quote. Half of the Community Revitalization Project has been extended to March 2021 as most projects won't begin until summer. Nancy MacKinnon asked if the outside building had been approved, it has, but awaiting for the weather to turn nice and it will be built on site.

Howard Ellis asked if we had gotten the quotes to go ahead with the bookshelves for Stanhope Place.

It was duly moved and seconded that Paul MacMillan be hired to complete the bookshelves at Stanhope Place for \$1275.

Gerard Watts discussed with the Committee what has been discussed in the Recreation regarding the ball fields and soccer fields. Riptide would like to have the second field at the North Shore Community Centre to use for softball, however, soccer has been using that area. Gerard said that the field owned by Myron MacDonald has been used in the past for soccer and cannot be used for softball. The Committee agreed and recommends to Council that the second ball field be upgraded for use of softball and soccer can move to Myron's field.
