4.1 Capital Projects Update

- Grand Tracadie Key Card Access is in progress. Software should be coming this week
- Security Cameras- have received 2 quotes, have some time as cameras can't be installed until Spring
- Outdoor storage shed at NSCC: waiting on garage door, should be coming soon
- Stanhope Oil Tank replacement: have received 1 quote, waiting on another company to come out and quote
- Chair lift/Elevator: upped budget of gas tax to \$50 000, there is 1 preliminary quote, we will need architect/engineer to come and see what we need
- Replacement of signs around the municipality: use CIP for gas tax for the signage, need to wait until current gas tax project is closed so can see how much is left
- Generator at Grand Tracadie: if there is a pandemic and an emergency at the same time, we will need a 2nd warming station, hence the need for a generator at Grand Tracadie. Hoping to use the Climate Challenge for 75% of cost and potentially use the Safe Restart fund for the remaining 25%. Waiting to hear about funding before finalizing.
- Audio/Visual upgrades: Screen/rear projector for the NSCC gym, has been quoted at \$22 000, proposing to use Safe Restart fund to cover the cost.

It was duly moved and seconded that Finance and Admin recommend to Council to approve the Screen and Rear Projector Project for the NSCC Gym using Safe Restart Funding

We need to identify commercial properties, they need to be identified before the Official Plan takes effect, this needs to be sent to Planning Board

Centre rentals/bar - reduce the budget income as not many events due to COVID

Wages: combine lines for "Administrator Wages" and "Centre Wages"

Ensure at least \$20 000 for upcoming studies

It was brought up that perhaps the Fire Department should be approached regarding Fire Dues. Asked for their Financials, should be on their website.
