Replacement sign for West Covehead, not in budget currently but will look at getting it repainted. Grand Tracadie School Centre signage –will be left for spring to put it in the budget.

Floating docks discussed on keeping them securely stored.

Stanhope Step installation was discussed. 911 number at Stanhope Place to be moved into proper position.
