4. REPORTS

- **4.1.** <u>CAO Report –</u> CAO presented written report. Still working with insurance to get Fiona claims completed. Working with Province to clarify responsibilities surrounding Promenade they are putting a plan in place to resurface broken asphalt, fixing culvert, and dealing with broken stairs at the end of Bayview Lane. Organizing a tabletop with Provincial EMO. Organizing a public event with Provincial Fire Smart Ambassador. Getting summer students and camps organized. Mayor discussed importance of reporting during fire bans as even small fires can get out hand quickly. The meeting with Parks Canada seems to be received well by the public. A thanks to them for expediting that meeting. Councillor Cook felt his being able to speak at that meeting provided clarity to role of EMO within the Municipality.
- **4.2.** <u>Finance and Infrastructure Report –</u> Finance Committee meeting was May 23, 2023. Discussions on the agenda for tonight, from that meeting, are the Mighty Oaks contract amendment for 2024 and investing 2022/2023 surplus into appropriate GIC. The final report for the 2022/2023 audit has not been completed so the \$40,000 surplus is just an estimate at this point. Infrastructure- we need to discuss with everyone involved regarding location of outdoor rec surface at NSCC before moving forward with quotes. Financial report CAO reported that wage recovery for the Development Officer will not show until June financial report. Large amount spent on rec supplies is referring to up front cost for Canada Day expenses. Councillor asked Capital Maintenance expenses were high in May 2023. CAO will look into this. Update from contractors regarding delay in getting the NSCC sign working they will be beginning work very shortly next rainy day.
- **4.3.** <u>Planning Board and Development Permit Report –</u> There has been no planning board meeting since the last Council meeting. There will be a meeting soon with rezoning requests. Councillor questioned if bylaw enforcement officer inspects properties without permits. It was explained that Bylaw enforcement & Development officer drive through the Municipality weekly and if there is development underway that they are not aware of than they will reach to the Province to investigate. There are ongoing projects that can still be covered by Provincial permits as they were started within the required timeline. If a questionable development is observed than it should be reported to ensure that it is brought to the Bylaw Enforcement officers attention.</u>
- **4.4.** <u>EMO Committee Report –</u> Meeting was May 16, 2023. Predominant topic was wildfires. Provincial forestry is in charge in the event of a wildfire. Very important that residents are careful with wildfire warnings. Every household should have a 72-hour contingency plan as well as an evacuation plan. CAO is working with PEI EMO to do tabletop exercises. Our Municipal EMO is essentially in charge of the warming center we do not have authority of fire and police. Councillor questioned building a shelter for the generator. Contractor is working on a plan for this.
- **4.5.** <u>Recreation Committee Report –</u> Meeting was June 12, 2023. Information requested from last Council meeting Riptide president has submitted a scope of the work. It was implied that this work would happen soon and with no cost to the Municipality. However after discussion with that company this project will take multiple weeks and cannot be started until the Fall of 2023 at earliest. CAO has requested quotes for having the property professionally surveyed. Councilor suggested we consider

- **4.6.** <u>Water, Bays & Environment Report-</u> The Bay has changed a lot since Fiona. Once Justin from FCBB is available they will coordinate to discuss the chanels. Councillor advised there is still testing being done on soil taken from test pond.
- **4.7.** <u>Stanhope Potable Water System</u> Committee met May 24th. Consultant sat in to go over report. Recommendation was to evaluate the potential well sites. Hoping that students can collect water sample data over the summer to collect additional data on possible salt water contamination. CAO suggested we request residents to forward the water samples that they have completed to her for collection and review.

It was duly moved and seconded: that we have one of our summer students to collect water samples from within our municipality so that we can acquire more data to more decisions related to water. As well as have residents submit their completed water sample results that have been collected from January 1, 2023 – August 30, 2023

The Municipality has invested in getting two ballfields at the North Shore Community Center to regulation size in the last few years. Councillor advised that in 2022 it was agreed that the 2 fields at the NSCC would be brought to regulation size and Grand Tracadie would stay as is. Chair of rec committee would like more communication with his committee as this is recreation.</u></u>**

This topic is tabled to a future meeting when a plan has been constructed for.

5.4. <u>RFD – 2023-027 – Contract amendment for Mighty Oaks Daycare for 2024</u>: at the May 23, 2023 Finance & Infrastructure committee meeting discussed amending the Mighty Oaks Daycare 2024 lease agreement to have the daycare take over cost of heat and electricity and reduce their rent accordingly. This adjustment will allow the daycare to utilize the building to their comfort without applying excessive cost to the Municipality. The final decision on the cost adjustment will go back to Finance Committee for review and Council for a decision before the 2024 lease agreement is created.
