5. RESIDENT PRESENTATION Jerry Muzika – Municipal Boundaries

Jerry spoke to Council on the importance of Municipal Boundaries, Jerry served on Council in Parkdale, PE for fifteen years and was around for the development of the Charlottetown Civic Center which was on the line between Parkdale and Charlottetown which would affect who serviced the water and sewer needs. Another example is when the QEH was built it was not on Municipal Property but all the surrounding Municipalities wanted on their respective properties.

6. **REPORTS**

6.1 Finance and Infrastructure:

Councillor Watts reviewed the Community Financials for the first quarter of the year, most items are on track.

Councillor Watts informed Council that the Finance and Infrastructure Committee reviewed installing a Card Access system that will tie into the alarm. This system will replace the current key and code system and allow the Administrator to program Cards for temporary and ongoing access and allow more control. This will also work well for people accessing the facilities on the weekends so that no one has to let them in.

It was duly moved and seconded that Council award the installation of the Card Access system to Provincial Alarms at a price of \$1,950 plus HST.

Councillor Watts reviewed the Heating and Cooling System upgrades that were included in the 2017 budget. MCA consultants report recommended going with a new cold start oil fired furnace and roof top heat pumps for air conditioning for the Center. ACOA may have some funding available for this project.

It was duly moved and seconded that Council apply for funding through ACOA from the Build Canada Fund to offset the cost of a new heating and cooling system.

Bylaw Second Reading

Community of North Shore Chair and Council Remuneration Bylaw

Bylaw # 01- 2017

A bylaw to provide Honorarium's for Chair and Council of the Community of North Shore.

WHEREAS Section 17 of the Municipalities Act R.S.P.E.I. 1988 Chapter M-13 provides that Councillors may, by bylaw set the level of remuneration payable to the Chair and Council.

AND WHEREAS The Community of North Shore is committed to provide residents that are elected to the positions of Chair, Vice Chair and Councillors reasonable remuneration for their service to the Community

BE IT ENACTED by the Council of the Community of North Shore as follows;

1. Title

This Bylaw shall be known as the "Chair and Council Remuneration Bylaw"

2. Remuneration

- 2.1 **The Chair** shall be paid remuneration for carrying out Council duties in the amount of \$2,000 (two thousand) per calendar year.
- 2.2 **The Vice Chair** shall be paid remuneration for carrying out Council duties in the amount of \$1,500 (one thousand five hundred) per calendar year.
- 2.3 **Each Councillor** shall be paid remuneration for carrying out Council duties in the amount of \$1,000 (one thousand) per calendar year.

3. Effective Date

The effective date of the bylaw is the date that the bylaw is formally adopted by the Council of the Community of North Shore.

4. Payment Schedule

Councillor Remuneration will be paid biannually in June and December of each Calendar Year

5. Attendance

Councillors will be deducted Remuneration for missed meeting's without just cause.
