5.3 EMO Committee - Councillor Pretty

Councillor Pretty reported that with the elections and a new council many of the members of the NSJEMO are interested in continuing to be involved with the committee. Councillor Pretty noted that NSJEMO had a like and share contest on Facebook to promote emergency measures and awareness of the NSJEMO. Councillor Pretty drew for the prize of a Red Cross 72 Hour Preparedness Kit - The winner was Nicole Cannell.

The Red Cross recently put on a mock emergency exercise to set up a warming station. The feedback from this event was very positive and NSJEMO will likely organize one sometime over the winter. NSJEMO is always looking for feedback.

5.4 Environmental Sustainability – Councillor Egan

Councillor Egan highlighted the following from Committee's report in Appendix B which includes a powerpoint update from MRSB. MRSB has completed the RFP for an Environmental Study of Covehead Bay, completed the terms of reference and steering committee recommendations and are working on the funding applications, there is still some work to be completed on the Covehead Bay Stakeholders Engagement.

Councillor Egan reported that with regards to the Marine Use Plan MRSB had meetings with DFO and the province and a Marine Use Plan is not something that the Municipality has the jurisdiction to develop or enforce. DFO has assured the Municipality that there will be a public meeting and public consultation period with regards to the Aquaculture review of Covehead and Brackley Bays, the committee has documents on this as well as the Covehead Bay Review. The committee suggests that the new Council should keep an eye out for the Aquaculture leasing policy review. The committee will provide any documentation that has been gathered over the past few years to the Municipal Office

Councillor Egan highlighted the committee's summary on the Water and Sewer file, North Shore has done a great deal of work on this and there are many reports available to be reviewed, this file should be addressed in the 2019 Official Plan update.

Jonathan will follow up with Derek to confirm that the work in completed.

5.6 Recreation and Community Engagement Committee - Councillor Sheehan

Councilor Sheehan read her report attached in Appendix C into the record and also highlighted that the Remembrance Day Event and Halloween Party were well attended. The 55 plus games have asked Charity to present a report at their December meeting and she will plan to present the report on behalf of Council.

The next recreation event is the Children's Christmas Party on December 9th. Councilor Sheehan reported that the Municipal facilities are well booked and that Recreation is important to the Community as well as having good staff people and volunteer's.

Environmental Sustainability Committee Update

November 14, 2018

 The 2018 Covehead Bay Study has identified two main priorities – a Covehead Bay Scientific/Environmental Study and Covehead Bay Marine Use Plan.

The Scientific/Environmental Study: The output from the MRSB project is that an RFP and terms of reference have been completed. The Steering Committee recommendations have been identified and several funding sources have been applied to. MRSB is still working on identifying other funding sources. See Appendix MRSB November 9, 2018 presentation for more detail.

The Marine Use Plan – DFO has indicated that this work is not within jurisdiction of the Municipality to implement or enforce. However, the Municipality will have an opportunity to have input into the upcoming Bay by Bay Review process. They will be completing an Aquaculture Leasing Zoning Review for Covehead Bay. No timeline has been set for this to be completed. See MRSB November 9, 2018 presentation for more detail.

There are studies and documents that would help in the presentation to DFO during the period for public input. Examples are the Covehead Bay Review, public emails and responses etc. DFO has stated that they will have a period of public consultation and a public meeting as part of the process.

PEI Aquaculture Leasing Policy is currently under review. A recommendation is to engage the province for an update and input. There was an analysis completed of the current leasing policy with some gaps identified and there are detailed information on this.

In summary, the ESC there has been a lot of detail and knowledge collected and meetings over the past two years. We will be sharing this information with the CAO and will be completing a handover of information.

2. Water and Sewer Assessments and Activities

The former municipality of North Shore has dedicated significant resources into water and waste water assessments and studies dating as far back as 2000. The ESC has completed a summary of the work completed and developed conclusions for the upcoming council to consider. See attached appendix.

In addition, there were meetings with the provincial specialists – Morley Foy to get an update on potential problem areas in the Community. These areas should be addressed during the 2019 Official Plan update to see how the Municipality can engage with the Province to monitor, manage and plan.

Executive Summary

Review of Water and Sewer Assessments and Activities

Rural Municipality of North Shore

November 14, 2018

Background:

Most residents and businesses in the Rural Municipality of North Shore are reliant on individual on-site sewage disposal systems and wells. The Municipality recognizes the importance of protecting the health and integrity of water and wastewater for now and generations to come.

The former Municipality of North Shore has dedicated significant resources into water and waste water assessments and studies dating as far back as 2000. This work has been funded by Provincial, Federal and Municipal Government sources to assess this important matter for the community and build recommendations. The following is a summary of the work completed to date and conclusions for the upcoming Council to consider.

Summary of Work Completed:

2001 Stanhope Point Water Study Summary – Water Feasibility Study by CBL Limited, Consulting Engineers

2004 North Shore Community Official Plan – recommendations to preserve integrity of the environment and groundwater quality.

2007 Engineering Study to investigate a conventional centralized water distribution system for the Stanhope Peninsula.

2009 Long-Term Water and Wastewater Servicing Study by Engineering Technologies Canada Ltd to investigate water and wastewater needs in more detail, as well as alternative options and approaches.

A Clean Water Committee was established to address action on the report. This committee recommended a number of educational, monitoring and regulatory actions to extend the life span of onsite water and wastewater systems on the Stanhope peninsula.

Shortly after the study was released, the Clean Water Committee disbanded due to changes in Council membership and shift in Council priorities.

2014 Community of North Shore Official Plan - developed recommendations for Water and Wastewater Management to encourage property owners to maintain or upgrade existing on-site water and/or wastewater systems to Provincial standards. It recommended the establishment of a special committee of residents and Councillors to study and report to Council on the adequacy and risks of on-site systems, an optimal approach to education, monitoring and best practices for Council and residents. The special committee would report to Council on steps the Community may consider in the event that this optimal approach to education, monitoring and best practices should be inadequate. Council did not act on this recommendation to establish a special committee.

2014 North Shore Summer Student Project – an engineering student was hired to collect information on wells, conduct a review of all studies completed to date and make recommendations to Council. From this, Council opted to begin with a focus on one of the recommendations to provide a healthy water and sewer educational strategy for the community.

2016 – present – Rural Municipality of North Shore Environmental Sustainability Committee (ESC) – established to support one of Council's strategic priorities – the Environment.

This committee, composed of 4 councillors, followed Council's directive by developing and implementing an annual "Healthy Water and Wastewater" educational program to:

- Remind all property owners to check on-site water and wastewater systems to ensure they
 meet provincial standards
- Distribute information on best management practices for on-site water and wastewater systems
- Educate about potential issues surrounding maintenance of on-site water and wastewater systems
- Stress importance of annual water tests, regular maintenance of on-site wastewater systems plus report any issues to community office to help identify any potential problematic trends.

In addition, to get an appreciation and knowledge transfer of the work completed to date, the committee reviewed all of the Water and Wastewater studies and data available, met with subject matter experts such as provincial officials.

Conclusions

As a result of the above review, consultations and work completed to date, the ES Committee has drawn the following conclusions:

- The crucial importance of a community having healthy water and wastewater systems and the importance of planning ahead is well recognized.
- Significant studies and resources have gone into gathering data over the past 18 years for the Community of North Shore with recommendations.
- As an initial response, positive steps have been taken through the Educational Strategy completed by Council via the Environmental Sustainability Committee.
- There are some areas in the community that are more at risk. After data analysis was completed in the 2009 study, the following statement was provided to the North Shore Community in a Provincial Government Presentation
 - "The water quality results for both chemistry and bacteria for the Stanhope area are typical for average results across the province. However, it is important to note that historically built up areas with small lots have found to develop major quality problems over time. The Provincial Department of Environment, Energy and Forestry indicate that the intensity of development and the trends toward more year round occupancy will

have an impact on water quality. In addition, somewhat unique to the Stanhope area is the fact that the area is almost surrounded by saltwater and as development increases, the availability of fresh water may become limited in certain areas due to salt water intrusion." Provincial Government Source Morley Foy, Approvals and Compliance Engineer. (Presented again to the ESC in the fall of 2018)

- There is a need for citizen, council and technical representation in order to build a plan to continue to address this concern. There is technical help available through Provincial Government and other subject matter experts to assist the community in planning and preparing for the future.
- There is now Federal Infrastructure funding available but it is time sensitive and limited. Communities across PEI have and continue to be proactive in planning to protect their water and wastewater systems where vulnerabilities exist and accessing funding to do so.
- There may be also other potential funding sources that can be used to best resolve the infrastructure requirements should such an approach be deemed necessary by the community. We have been advised that any infrastructure initiated within the community would be done so based on a user pay model.
- There are various infrastructure models to be explored that may be less costly and instrusive such as clustered well water systems.
- The problems that could occur in the future are the ones that need to be planned for now because there is a significant lag time to implement infrastructure solutions. Citizens are counting on Council's leadership for ongoing attention, planning, and consensus-building as to the road ahead.

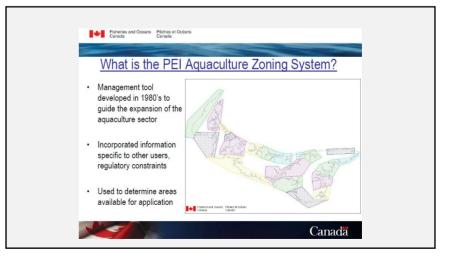

- No PEIAA member on Zoning Renewal Committee, as direct involvement with leasing renewal process could create conflict of interest.





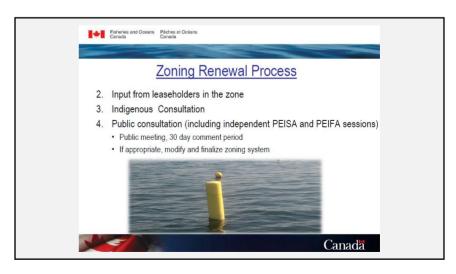

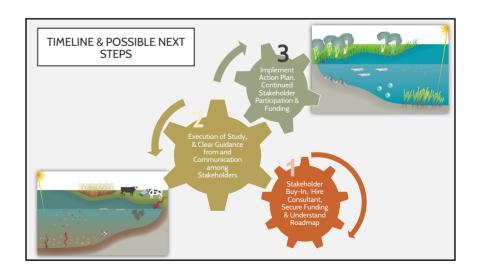

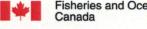

North Shore Community Council 2017 Operating Grant Request

Introduction:

The Friends of Covehead-Brackley Bay Inc. (FCBB) is a community based volunteer organization that was formed in 2001 by a group of community members concerned with the health and sustainability of the Covehead-Brackley watershed area. A Watershed Management Plan was developed in 2009, and the group achieved charitable status in 2012.

FCBB's mandate is: "to create a watershed area that is healthy: one which nourishes the land and water, one which is sustainable to native flora and fauna, and also balances the interests of residents, including those working in aquaculture, forestry, agriculture, fisheries, and tourism."

Basic Activities: FCBB annually maintains, protects, restores, and enhances, over seventy kilometers of stream in our six rivers that empty into our two bays. FCBB has built numerous bridges and public access docks, completed various sedimentation detention projects, planted thousands of native long-lived tree and shrub species, collected and compiled large amounts of data pertaining to the overall health of our drainage basin all the while encouraging community involvement and ownership of the watershed. FCBB has many working relationships within the watershed including and not limited to: Parks Canada, the of North Shore Community Council, Agriculture Canada, Department of Fisheries and Oceans, Canadian Wildlife Federation, Ducks Unlimited, and local agriculture producers, etc.

Projects: FCBB has been successful in planning and carrying out numerous projects over the last twenty years. FCBB has partnered with dozens of groups to provide an essential service to our watershed and the various communities and residents in our watershed. FCBB has been succeeded by forming partnerships across the country ranging from large federally funded organizations down to the smallest of land owners within the watershed. FCBB works with a budget of approximately a hundred thousand dollars per year and completes multiple projects annually. In FCBB's twenty years of operation our group has always completed every project it has taken on and has demonstrated a high level of value, competency, and efficacy in the work provided to our community.

Request & Usage of Grant:

FCBB has annually received this operating grant of \$1750.00 from the NSCC for almost ten years and the two groups have had a productive and health working relationship spanning decades. FCBB has been providing an essential service to the North Shore Community primarily thanks to the dedication of council and concerned local residents. FCBB has annually used the operating grant of \$1750.00 to pay the annual rental fee on the office space provide in Stanhope Place and will continue to use the grant (if awarded in 2018) for this same purpose. In 2018 FCBB is requesting the NSCC Grant and FCBB's rent both be increased to \$4000, because if FCBB has more operating expenses, these expenses can be used as in-kind matching expenses in project funding proposals. These expenses can therefore be used to leverage more funds for projects within our community.

The office space provided in Stanhope Place is critical to the annual and day-to-day operations of the watershed. This office space is not only a central location within the watershed to store equipment, but it has also provided the community a recognizable location where they can go to ask questions and raise concerns about the health of their environment. This office space has also been the gathering place for numerous watershed resident, funding provider, and various Provincial and Federal Government meetings that have resulted in a lot of meaningful improvements to our environment and the community. Having a reliable and consistent office space within the community has allowed the watershed to focus on raising awareness within the community on the importance of environmental stewardship, and improving our riparian habitats for aquatic and wildlife species. Thanks to the support of council FCBB has raised over \$600,000 for environmental projects in our community and has employed more than 60 local secondary and high school students over the last two decades. FCBB foresees the working relationship between FCBB and the North Shore Community only growing in the future and looks forward to improving our Community together.
