To the Mayor and Council of the Rural Municipality of North Shore,

Congratulations on the new council following the recent elections and expansion of the municipality. This new expanded municipality now includes areas of the Winter River - Tracadie Bay Watershed Association (WRTBWA) management area. There have also been recent changes in the boundary line between the Friends of Covehead and Brackley Bay (FCBB) and WRTBWA. Therefore, we are providing the following map showing how your municipality area is spread across these two watershed groups.



Figure 1. Municipality overlap with watershed groups: approximately 4310 ha with FCBB (green) and approximately 2880 ha with WRTBWA (blue).

We were contacted recently by Nancy MacKinnon regarding potential office space at the old Grand Tracadie School. We had approached the Grand Tracadie Community Council about renting space in this location in 2015, but we were told it was not available. Therefore, we continued our search and found an office location on the St. Peters Road in Marshfield. This has proved to be a convenient location for our staff, board members, and residents of the community. We learned that FCBB has an office space in Stanhope Place, and according to documents online, this space has been provided to the group at no charge. We also learned that the municipality has provided support for FCBB, in the amount of \$1,750 in 2016 and 2017. We were advised by a community member that our watershed group would also qualify for similar financial support.

Some past projects we have completed in the areas of your municipality where we work include: forest enhancement and fish habitat enhancement in streams near Friston Road, Pleasant Grove Rd and Suffolk Road; shoreline cleanups around Tracadie Bay including Grand Tracadie; tree planting at the Grand Tracadie ballfield and school properties; outdoor recreation events such as snowshoe hikes throughout the watershed; and water quality monitoring in springs, streams, river, and bay. This year we plan to complete more shoreline cleanups, and possibly some tree planting. Some potential future projects of mutual interest may include tree planting, educational events, outdoor recreation, technical support for Tracadie Commons, and water quality testing for homeowners.

Since we are unsure of the changes in revenue for the municipality given the merger with Pleasant Grove and Grand Tracadie, it would be difficult to for us to suggest an amount of funding from the municipality to our group. We would like to meet to discuss funding support for watershed groups and projects of mutual interest.
