5.4. Water and Environment Committee

Minutes from the Oct 7, 2019 meeting (Appendix B)

Chairperson Wanson Hemphill discussed the Public Meeting on Biosolids and Sewage Sludge with Morley Foy and George Somers from Monday Sept 30th at 7pm at the NSCC. A question that was brought forward was whether Council had jurisdiction to restrict the spreading of the Bio solids and sewer sludge. After posing the question to Municipal Affairs, Samantha Murphy answered stating that Council is able to make a Bylaw restricting this but should ensure they have a lawyer review it and are currently unable to restrict the spreading of Biosolids until such Bylaw is in place. CAO Stephanie Moase mentioned there is a current request from the Province for a new Application so a decision to move forward is requested from Council at this time to either allow the Application or move forward with a Bylaw to restrict it. Councilor Wanson Hemphill requested that we ask for notice from the Province prior to Application and the information of the Quantity and Quality of the material being spread as well as the PID for the field it is being spread on.

It was duly moved and seconded that the Council continue to allow the Province to approve Applications of Spreading Biosolids and Sewer Sludge within the Rural Municipality of North Shore

5.5. <u>EMO Committee Report</u>

Chair Derek Cook reported that the Committee met on Oct 2 and had a very good discussion regarding how the Committee was able to be effective in the aftermath of Hurricane Dorian. Discussed the direction they would like to go in and will be adding some Committee members and delegating the roles. Will continue to work towards completing the EMO Management Plan. The Rural Municipality of York will be officially joining the Joint EMO.

5.6. Planning and Development Committee

Chairperson Krista Shaw reported that she and CAO Stephanie Moase met briefly with Derek French, Development Officer, to get an idea of where the Planning Board stood. There was only one Development permit approved for the Month of September. Going forward all approved applications will be reported with the name, PID, permit number, address and type of permit. This will also be posted on the website for Public information. (Appendix C)

5.7. Recreation and Community Engagement Committee

Chairperson Bob Doyle highlighted a few points from the Oct 8, 2019 Meeting Minutes (Appendix D) Welcomed new Recreation and Events Coordinator Jennifer Blair. They are working with her and the CAO with preparations for the Children's Halloween Party and Remembrance Day Service. Committee discussed the option for a Community School in Grand Tracadie for the winter session. Committee recommends to Council to go forward with the Community School.

Councilor Bob Doyle felt this endeavor should be under it's own Community committee separate from the Recreation Committee and they would report back to the Recreation Coordinator and the CAO not to the Recreation Committee.

Councilor Krista Shaw inquired about parking for the school in Grand Tracadie. Mayor Gerard Watts mentioned that Council had requested to Department of Highways to fill in and pave along both sides of the entryway to Grand Tracadie and was expecting it would be done this fall.

5.8. <u>Bays Sustainabilty Committee Report</u>

Chair Mayor Gerard Watts reported that there was a Meeting of the Committee on Sept 23, 2019 although not everyone was able to attend. The main goal was to complete a Mandate for the Committee. There was a lot of great discussion and good feedback. (Appendix E) Final recommendation will be brought to Council after next meeting. Sarah Stewart Clark accepted the role of Co-chair.

Councilor Wanson Hemphill mentioned that he made a presentation on the health indicators of the Bay and types of Erosion in the Covehead Bay.

5.9. Monthly Financial Report

Mayor Gerard Watts presented the September Financial Report. (Appendix F) He reported that after consultation with the CAO and the Bookkeeper a decision has been made to add a column in the next months report that will show finances for that particular month in addition to the Year to date. Currently there is a surplus of about \$17,206. Currently 50% through the year and feels like we are still on track even though Development permits are a little down. Reminded Council that our year-end is now March 31st, not December as in previous years.

6. **NEW BUSINESS**

6.1. Capital Investment Plan

CAO Stephanie Moase referred Council to the Capital Projects list in the CAO Report. A CIP has been done to capture the 50% not covered by the same projects that have already been applied for. CIP Grand Tracadie School Upgrades – \$83,467

Also two other CIP' have been created to cover Projects already Recommended to Council.

CIP North Shore Accessibility - \$31,487 (for handrails and a chairlift)

The chairlift had previously been applied for through the New Horizons Program but was denied. It was not applied for through the Community Revitalization Program as we had exceeded our budget for this year. We will be able to re-apply for this in the Spring and may be able to get 50% for the Chairlift Project at that time. CIP's are required to be applied for to cover the whole 5 year period to encourage Councils to be thinking ahead about what Capital Projects are required in the future.

CIP Official Plan Review- \$9,361

%50 of this project has already been approved for through the Municipal Strategic Component stream of the Gas Tax Funds. The other %50% had been applied to Through the Province's Capacity Building Fund but recently found out this may not be approved. As a precaution a CIP was created to capture this cost. If the Capacity Building Fund is denied and the Notional Gas Tax CIP is used for the Official Plan Review only an additional 40% of the total can be approved leaving 10% coming direct from the Municipality's fund (about \$2175)

6.4. Resident Inquiries

Councilor Krista Shaw said that the Stanhope Wharf is very messy and crowded. Mayor Gerard Watts has spoken to the Harbour Authority in charge of the wharf and was told the persons responsible for the mess will be cleaning it up

Councilor Krista Shaw had a request from a resident for access to the complete file for an approved development permit prior to the end of the 21 day appeal window. CAO Stephanie Moase stated that new Draft Access to Information Regulations are in process by Municipal Affairs but not completed and with the absence of a Municipal Access to Information Bylaw or Policy the issue reverts back to the MGA which states that for protection of privacy only the actual permit, not the application and supporting documents is available for Public Access.

Councilor Krista Shaw had a request from a resident regarding new Funds for Broadband. Will the Municipality be looking at this. Mayor Gerard Watts stated the we may need more information on what this is about before commenting. Councilor Peter Vriends suggested getting in touch with Joe Rowledge on this matter.

Councilor Derek Cook inquired about the widening of the Eastern Rd. Mayor Gerard Watts stated he has been working with the MLA on this issue.

7. CORRESPONDENCE

7.1. Letter from Public Services and Procurement Canada regarding surplus Federal Property

(Appendix G) DFO is divesting of the Stanhope Wharf, letter states that they are currently working with the Province but would like to know, if talks break down, would the Municipality still be interested in taking ownership of the wharf. Mayor Gerard Watts stated that a letter has been sent responding that the Municipality would be interested in taking ownership of the wharf if the Province were to decide not to.

7.2. Letter from Department of Finance regrading Grant in Lieu for PID 142372

(Appendix H) A Grant in Lieu was granted to each property except the Tracadie Commons. Department of Finance letter states that the Tracadie Commons is not eligible for a Grant in Lieu as it is vacant land. The tax due is \$658, Council agrees that this should be paid up. Councillor Wanson Hemphill also suggested sending a letter to the MLA asking why we are required to pay tax on a property that we do not actually have a clear title to.

The new Provincial Water Act has been approved but the withdrawal portion of the Act was still open for public input, the Committee had no comments to add to the Public Input.

5.5. Mayor's Report

Mayor Gerard Watts reported that he has been busy with the preparation for the new CAO and orientation with her. Attended the Finance and Admin Committee meeting. Looking into Highspeed internet and the Province is yet to sign anything with the suppliers, so it could still take time. Tracey Allen with FPEIM will be helping communities out with the website. Looking into getting an RFP out for legal representation this fall, usually done every three years just to ensure we are getting the best price. Mayor Watts has asked Councilor Krista Shaw to take over Chair of the Planning Board Committee as Councilor Derek Cook will have a lot on his plate coming up with the new Emergency Measures Plan required. Looking into a situation that has just come to light that the Grand Tracadie Recreation Committee had a signed agreement with the Red Isle ATV group to allow for trails to be made in the Tracadie Commons land. We will get a copy of the contract to see if this is in fact a binding agreement.


